**ANNOUNCEMENT**

**for the selection of a transnational partner in order to submit and implement a project under the Erasmus+ programme, Key Action 2, strategic partnerships in the field of youth**

in accordance with the provisions of art. 28-29 from Government Emergency Ordinance no. 40/2015-financial management of EU funds for the programming period 2014-2020, as amended and supplemented, Vaslui General Directorate for Social Welfare and Child Protection selects a transnational partner in order to submit and implement the project entitled "Tinerii noștri în derivă" (Young and Adrift)

The overall objective of the project is to reduce the number of manifestations of behavioral deviance among youngsters coming from the child protection system, which ensures their social integration. Main activities of the project partner:

- Project Management,
- Study on the influence of the types of protection measures on the psychosocial development of young people
- Delivery of training modules for youth workers
- Personal development modules
- Assessment
- Results dissemination and exploitation

Participants in the selection procedure must meet the conditions stated below:

1. Be legal entities registered and established in Programme Country or in any Partner Country in the world (see section „Eligible Countries” in Part A of Erasmus+ Programme Guide 2018)
2. Be non-profit making organizations,
3. Be directly responsible for the management of the project, not acting as an intermediary,
4. Have stable and sufficient sources of finance to ensure the continuity of the organizations throughout the project duration
5. Have no debts to the consolidated state budget or to the local budget in accordance with the national legislation
6. Not fall into any of the situation listed below:
  - They are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended activities, are the subject of proceedings concerning those matters,
  - They or persons having powers of representation, decision making or control over them have been convicted of an offence concerning their professional conduct by a judgment of a competent authority,
  - They, or persons having powers of representation, decision making or control over them have been the subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organization, money laundering or any other illegal activity,
  - They are subject to a conflict of interests; the conflict of interests represents any circumstances that may affect the evaluation or implementation process, in an objective and impartial manner. Such circumstances may result from economic interests, political or national preferences or family connections.

7. Field of activity: socio-educational. The partner must demonstrate experience in working with young people with conduct disorder and experience in the training of social workers

In order to participate in the selection, interested organizations must provide the following documents:

- Presentation of the organization (its type, size, scope of work, areas of specific expertise, specific social context and its activities and experience of the organization in the field of behavioral disturbance and training of youth workers)
- CV for 2 experts on the topics listed above (behavioral disturbance and training)
- Solemn declaration that they meet the eligibility criteria.
